2:45-4:00 pm **Modifying Previous Government Energy Policies: Options for Action in the Public Interest**

Ontario electricity ratepayers are paying for expensive Feed-In Tariff Contracts and the growing financial costs associated with an electricity price reduction scheme. This panel will be focused on identifying the tools and options available to new governments to deal with the policies of predecessor regimes, such that these policies do not bind the discretion of future governments or live longer than the electorate may decide they should. There are a range of options available to government to deal with these Feed-In Tariff Contracts, from letting the customer pay (the current approach), to contract cancellation, and a number of options in between. The panel will engage in a fact-based discussion on the policy options available and the factors that must be considered when making a policy decision to act.
